## **GAR Foundation - Essential Experiences Initiative**

The Board of Education of the Akron Public Schools (APS) and GAR Foundation entered into a Memorandum of Understanding (MOU) on March 11, 2019, wherein GAR Foundation dedicated funds in the amount of \$1.2 million over a three (3) year period to support essential experiential learning activities for APS elementary students in grades Pre-K through fifth, effective March 12, 2019 through March 11, 2022. At the Board Meeting of February 14, 2022, a new MOU was established between GAR Foundation and APS for the renewal of the Essential Experiences Initiative for an additional three (3) year period in the amount of \$2.2 million, effective February 15, 2022 through February 14, 2025.
