I wish to recommend entering into a Memorandum of Agreement (MOA) between the Akron Public Schools and The University of Akron to offer a Sterile Processing/Central Service Tech program for students enrolled at East CLC, Garfield CLC and North High School's medical pathways, which is a field dedicated to supporting the healthcare industry with supplies and equipment. The program teaches students the sterilization practices that will prepare them to become a Certified Sterile Processing and Distribution Technician with topics that include: microbiology, infection control, decontamination, manual and mechanical cleaning, instrument inspection and assembly, sterilization procedures and methods, sterile storage, inventory control, material management and distribution. The class format includes lecture, demonstration and practice and upon completion, students will be eligible to take the Certification Board for Sterile Processing and Distribution (CBSPD) Exam.

The total cost not to exceed of \$30,000.00 includes participant materials, textbooks and certification exam, to be charged to Fund 001-0000 (General Fund).
